### ***Annual report of the chairman***

Karol Daucik went through his report, see Annexe 1. The first year of SIAPWS has been one of consolidation. The international organisation IAPWS has approved the change of the Danish committee to the Scandinavian, SIAPWS, and the Danish Association of Engineers, IDA, has accepted to host the new committee and function as the general office of the committee. Prior to this general meeting the Danish committee had unanimously decided to merge with the SIAPWS, and all formalities were thus in place for the new committee.

### ***Report on the financial situation***

Karsten Thomsen gave a short summary of financial situation as taken over from the Danish committee. The capital of SIAPWS is now 197.007 DKR and that is expected to grow in the coming years. The next international meeting to be held in the Scandinavian region is expected to take place in 2014 or 2015, and arranging this is expensive. Thus, it is necessary to save up for these special occasions.

Siemens Industrial Turbomachinery wants to be a company member from 2011. Vattenfall, Ringhals considers if they want to have the same affiliation.

Matarvattensektionen is a corporate group member in 2011 and 2012 also, and then it has to be decided how to continue. One possible practical way is that the major members/-companies in Matarvattensektionen pay the company fee whereas the smaller companies continue to be members through the Matarvattensektionen.

### ***Election of the vice chairman***

The executive committee had suggested Mats Hellman who represents Matarvattensektionen as the vice chairman, and this suggestion was approved.

### ***Technical subject***

Karol Daucik presented a comparison of Danish, Finnish and Swedish recommendations for water chemistry of drum boilers see Annexe 2.

### ***Any other business***

Karsten Thomsen suggested that the executive committee should consider an SIAPWS arrangement in combination with the conference, Matarvattenkonferensen, held by the Matarvattensektionen every year in November. It is important with PR to make SIAPWS known and accepted in Scandinavia and the conference is a good opportunity to contact many of the Swedish and other Scandinavian companies.

The suggestion was approved by the meeting and possible subjects could be a closer look at the chemical guidelines already published by IAPWS and comparison with practice in Scandinavia, e.g. comparing Karols overview of water chemistry of drum boilers with the IAPWS guideline on the same subject.
